Re: Draft Wind Energy Areas – Commercial Leasing for Wind Power Development on the Oregon Outer Continental Shelf

Dear Jean,

The American Albacore Fishing Association (AAFA) and Western Fishboat Owners Association (WFOA), representing the commercial north Pacific albacore fishery (fishery) operating off the U.S. west coast, request a 30-day extension of the comment period for the Draft Wind Energy Areas (DWEAs) off the Oregon Coast, until November 15, 2023.

The fishery typically operates between July and October and this year is no different. As a user group who would be directly impacted by developments within these draft Wind Energy Areas, via loss of important fishing grounds, the extension would provide fishery participants sufficient time to review the DWEAs and accompanying *Draft NCCOS Report: A Wind Energy Area Siting Analysis for the Oregon Call Areas* (Aug. 2023) in order to offer informed and detailed comments and recommendations.

The fishery is prosecuted by vessels using troll gear as well as pole and line gear. Between 2012 and 2020, an average of 570 vessels participated in this important fishery, catching 10,300<sup>1</sup> metric

tons generating roughly \$38.4M in ex-vessel revenues<sup>2</sup> annually<sup>3</sup>. Each of these vessels are small businesses, many family-owned, that provide food security to the nation as well as jobs and economic benefits to fishing communities up and down the west coast. Our memberships span the coast from San Diego, California to Bellingham, Washington.
